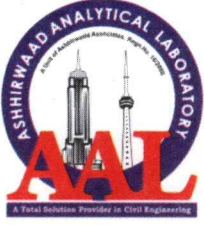



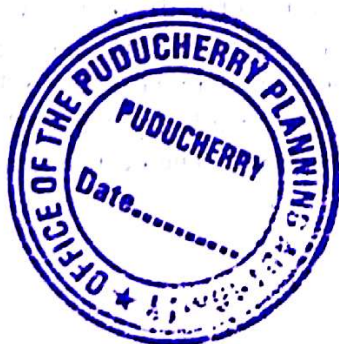
The licence is not transferable to any other person and should be produced by the Licensee whenever required to do so by the Chairman.
