- Maharishi Institute of Creative Intelligence will support and assist with Sri Ganesh Educational Trust to run their school in the name and style of Maharishi Vidya Mandir, Sri Ganesh Educational Trust No 368, 2 Floor, Anna Salai, Pondicherry- 605001, A unit of Maharishi Vidya Mandir Group of Schools.
- In its part, Maharishi Vidya Mandir, Chetpet, Chennai will support Maharishi Vidya Mandir, Keelparikalpattu Road, Pondy-Cuddalore ECR Road, Bahour Commune, Mullodai, Pondicherry- 607402, in appointment of Principal, Teachers and other Staff Members whenever it is required.
- Academic support will also be available in the form of arranging the Assembly, Prayer,
 Framing of Syllabus, Curriculum, Time-Table, Allocation of work to the Staff Members
 framing of Question Papers, Preparation of Key for Answer Papers and correction of random
 Answer Papers etc., meticulously.
- 4. Maharishi Institute of Creative Intelligence Initiators will train children in learning Transcendental Meditation, Yoga, Pranayama and T.M. Siddhi Techniques to staff Members of Teaching and Non-Teaching and students from Class III upwards.

- Maharishi Vidya Mandir, Chetpet, Chennai will arrange in Service Programmes, twice in a year with six days duration.
- 10. With the consent of both parties and with the relevant approvals from various authorities the school can be re-located at any other suitable location.
- 11. Tenure of the Agreement: This agreement shall be valid as long as both the parties are willing to run jointly a CBSE school at the above premises and the financial terms as mentioned in point no . 13. Shall remain unchanged.
- 12. Sri Ganesh Educational Trust shall provide for all the expenditure of establishment of Maharishi Vidya Mandir, Sri Ganesh Educational Trust, Keelparikalpattu Road, Pondy - Cuddalore ECR Road, Bahour Commune, Mullodai, Pondicherry – 607402 including maintenance and running the school with utmost efficiency and high standards. Sri Ganesh Educational Trust shall also provide for all travelling and incidental expenses of Maharishi Institute of Creative Intelligence during, running of Maharishi Vidya Mandir.
- 13. <u>Financial Terms:</u> In consideration of the Management of Maharishi Vidya Mandir, Chetpet in supporting and establishing Maharishi Vidya Mandir, Keelparikalpattu Road, Pondy-Cuddalore ECR Road, Bahour Commune, Mullodai, Pondicherry 607402 and for giving total academic support Sri Ganesh Educational Trust agrees to pay as per the terms mentioned below.

The payment shall be agreed to be paid as follows:-

First Five years (2020-21 to 2024-25) - Rs. 6,00,000 per year (Rs. Six Lakhs only).

Next Five years (2025-26 to 2029-30) - 5% of the fees received. From Eleventh year (2030-31 onwards) - 4% of the fees received.

The term fee refers to all kinds of fee collected from the students for the purpose of education viz Tuition fee, Lab fee, Sports fee etc. but does not include Capitation fee, Transport fee, Building fund or Capital donation etc, books and other deliverable fee, excursion, co-curricular fee etc.

The above fee does not include any fee collected from the students on behalf of any outside institution of agency or authority where such fee does not accrue to the income of the school.

In case of fee collected for outsourced service eg IIT / NEET Coaching etc, fee for the above calculation shall be nett after payments to such service provider.

- 14. The above payment will be made to `Maharishi Vidya Mandir Vedic Education Project a/c' on or before March 31st of every Calendar year.
- 15. The Managing Committees of both the Institutions will meet together and pass resolutions to pave way for smooth functioning of the school.
- 16. Any misunderstanding between the schools will be sorted out by the Management of both the parties with a concept of mutual understanding.
- 17. The curriculum will be solely decided by Maharishi Vidya Mandir, Chennai under NCERT Pattern. The books prescribed by Maharishi Vidya Mandir, Chennai will be followed in letter and spirit.

However school can place order for note books with their chosen vendor.

- 18. The MOU is applicable incase of change of Correspondent, Chairman or change of Society also. It is a perpetual agreement and cannot be changed at any cost.
- Inspection will take place twice in a month by the Inspector and Senior Teacher from Maharishi Vidya Mandir, Chetpet, Chennai. Full co-operation should be extended to the Inspection team. All travelling, boarding, lodging and incidental expenses will be borne by the school concerned and not by Maharishi Institute Of Creative Intelligence / Maharishi Vidya Mandir, Chennai.
- 20. All Inspection reports will be sent to the Correspondent / Principal for which reply should be given within a weeks time. This will improve the quality of the school.
- 21 All correspondences related to Academics will be sent to the Principal, whereas Correspondences with regard to Administration will be communicated to the Correspondent.
