Whereas under deed of Trust dated 18th June 2007 (Registered as Document No.666 of 2007, Office of District Registrar, Puducherry) Mr. S. Selvamani, the Author of the Trust executed the "Deed of Trust " in the name of "SRI GANESH EDUCATIONAL TRUST" and carried out the Trust which embodied the following trustees of the trust viz.

3. Mrs. S. Thillaikarasi W/o S. Selvamani aged about 55years residing at No.8, Zemindar Garden, S.V. Patel Salai (via), Pondicherry 605 012.

Whereas, considering the expansion of activities and necessity of the sharing of assignments and as per Clause 5(d) of the trust deed, the trustees of the trust hereby agreed to appoint one more trustee to share the administration assignments.

Accordingly Mrs. D. Prema W/o S. Deepak aged about 34 years residing at No.8, Zemindar Garden, S.V. Patel Salai (via), Pondicherry 605 012 (PAN No. CKQPP0319H) (who is having very rich experience in the administrative matters) agreed to act as trustee of the trust.
