- 2. Rainwater harvesting measures as shown in the approved plan should be followed.
- Cloth or plastic sheet is mandatory for spreading and keeping construction materials on the roadside / pedestrian platform, in order to prevent scattering of materials. Necessary permission shall be obtained from the concerned Municipality/Commune Panchayat/PWD for stacking of materials on the roadside land.
